THE EXTENSION OF THE FURLOUGH SCHEME

Context

As England enters a second national lockdown, businesses and their employees have been anxious to know if their finances and jobs will be protected.

On Thursday 5 November, the Chancellor announced that the Coronavirus Job Retention Scheme will be extended until the end of March 2021

In this briefing paper, the eighth in our series, 'Managing the Impact of Coronavirus', we explain how the furlough scheme works and analyse what this means for our members.

What is the Coronavirus Job Retention Scheme?

The Coronavirus Job Retention Scheme (CJRS) is a temporary scheme which enables employers to recover 80% of wage costs for employees who are furloughed.

'Furlough leave' is a new classification of indefinite leave where the government will reimburse the employer for wage costs.

The scheme was introduced as an alternative for employers who might have otherwise implemented redundancies, lay-offs, unpaid leave, or other measures for their employees.

The scheme allows employers to claim for 80% of furloughed employees' usual monthly wage costs, up to £2,500 a month, plus the associated Employer National Insurance contributions and minimum automatic enrolment employer pension contributions on that wage.

Employers will be able to use this scheme at any time during the next five months.

How long will the scheme be available?

The scheme has been extended until the end of March 2021 for all parts of the UK.

The Government will review the policy in January to decide whether economic circumstances are improving enough to ask employers to contribute more.

Who is eligible for the scheme?

For employers:

All UK businesses with employees can apply for the scheme, including:

- Businesses
- Charities
- Recruitment agencies (agency workers paid through PAYE)
- Public authorities

Employers do not need to have used the furlough scheme previously.

Employers across the UK can claim, whether their businesses are open or closed.

The Government expects that publicly funded organisations will not use the scheme, but partially publicly funded organisations may be eligible where their private revenues have been disrupted.

For employees:

Employers can claim for employees who were employed and on their PAYE payroll on 30 October 2020. This includes:

- Full-time employees
- Part-time employees
- Employees on agency contacts (who are not working)
- Employees on flexible or zero-hour contacts

The scheme also covers employees who were made redundant since 23 September 2020, if they are rehired by their employer.

Employers will have the flexibility to use the scheme for employees for any amount of time or shift pattern, furloughing employees on either a full-time or part-time basis. Employers will be able to vary the hours worked in agreement with the employee.

Employees do not need to have been furloughed previously to be eligible for the scheme.
